ORDINANCE 0-11-2019

AN ORDINANCE REPEALING ORDINANCE O-25-2008, PASSED OCTOBER 20, 2008, ADOPTING AND PROMULGATING A "POLICIES AND PROCEDURES MANUAL" AND "RULES AND STANDARDS OF CONDUCT," FOR THE FORT THOMAS POLICE DEPARTMENT, AND ALSO REPEALING SUBSEQUENT AMENDMENTS AND ADDITIONS BEING ORDINANCE O-02-2010, PASSED MARCH 15, 2010; ORDINANCE O-19-2010, PASSED DECEMBER 6, 2010; ORDINANCE O-20-2011, PASSED NOVEMBER 7, 2011; ORDINANCE O-06-2014, PASSED JUNE 16, 2014; ORDINANCE O-13-2016, PASSED JANUARY 3, 2017; ORDINANCE O-05-2017, PASSED JUNE 19, 2017, AND ORDINANCE O-11-2017, PASSED NOVEMBER 20, 2017.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNCIL OF THE CITY OF FORT THOMAS, CAMPBELL COUNTY, KENTUCKY, AS FOLLOWS:

SECTION I

That Ordinance O-25-2008, passed October 20, 2008, adopting a "Policies and Procedures Manual' and "Rules and Standards of Conduct" for the City of Fort Thomas Police Department is repealed.

SECTION II

That Ordinance O-02-2010, passed March 15, 2010, relating to adding policies pertaining to foot pursuit, Safe Infant Act, Golden Alert, missing persons, limited English proficiency, evidence and property management and firearms care, usage and maintenance is repealed.

SECTION III

That Ordinance O-19-2010, passed December 6, 2010, relating to use of force is repealed.

SECTION IV

That Ordinance O-20-2011, passed November 7, 2011 relating to definition of terms, department structure, classification and delineation of duties and responsibilities, direction general management, training, records and reports, complaint procedure, vehicle maintenance and care, body armor, laws of arrest, defendant's rights at the time of arrest, in-car video storage and use, investigations overview, evidence collection, and personal adornment be repealed.

SECTION V

That Ordinance O-06-2014, passed June 16, 2014 relating to general management, performance evaluations, rifle policy, complaint procedures, forfeiture of assets, informants,

interviews and interrogations, confidential fund, general patrol, traffic law enforcement, domestic violence, juveniles, prisoner transportation, traffic control, vehicle impoundment, blood-borne pathogens, mutual aid for unusual incidents, radio communications, active shooting response plan, search and seizure, and bike patrol be repealed.

SECTION VI

That Ordinance O-13-2016, passed January 3, 2017 relating to sexual assault investigations be repealed.

SECTION VII

That Ordinance O-05-2017, passed June 19, 2017 relating to body worn video recorders be repealed.

SECTION VII

That Ordinance O-11-2017, passed November 20, 2017 relating to outside city details be repealed.

SECTION VIII

That this Ordinance shall take effect from and after the earliest date provided by law and following its adoption and publication as required by law.
