

**ORDINANCE NO. O-03-2020**

**AN ORDINANCE AMENDING ORDINANCE O-16-2013 ADOPTED ON OCTOBER 7, 2014 AND ORDINANCE O-19-2013 ADOPTED ON JANUARY 21, 2014 CODIFIED IN CHAPTER 111.09 CHANGING THE TIME WHEN DISTILLED SPIRITS, WINE AND MALT BEVERAGES MAY BE SOLD AT RETAIL WITHIN THE CITY OF FORT THOMAS FROM 11:00 A.M. TO 9:00 A.M.**

WHEREAS, the sale of alcoholic beverages in the City of Fort Thomas is presently allowed to begin at 11:00 a.m. on Sunday; and,

WHEREAS, the City Council deems it appropriate to authorize the sales to begin at 9:00 a.m. on Sundays;

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF FORT THOMAS, CAMPBELL COUNTY, KENTUCKY:

**SECTION I**

That Title XI, Business Regulation, Chapter 111, Alcoholic Beverages, Section 111.09 (A) and Section 111.09 (B) of the Fort Thomas Code of Ordinances relating to hours of operation for the sale of alcoholic beverages on Sundays be and is hereby amended to read as follows:

**§ 111.09 HOURS OF OPERATION**

(A) No holder of a NQ-2 Retail Drink License, NQ-3 Retail Drink License, NQ-4 Retail Malt Beverage Drink License, Quota Retail Drink License, Microbrewery License or Special Temporary License may sell alcoholic beverages at retail by the drink between the hours of 2:30 a.m. and 6:00 a.m. of any day, except Sunday. On Sunday, no alcoholic beverages may be sold at retail by the drink between the hours of 2:30 a.m. and ~~11:00 a.m.~~ 9:00 a.m.

(B) No holder of a NQ Retail Malt Beverage Package License or Quota Retail Package License may sell alcoholic beverages at retail by the package between the hours of 12:00 a.m. and 6:00 a.m. of any day, except Sunday. On Sunday, no alcoholic beverages may be sold at retail by the package ~~except between the hours of 11:00 a.m. and 12:00 a.m.~~ between the hours of 12:00 a.m. and 9:00 a.m.

**SECTION II**

All ordinances, resolutions or parts thereof, in conflict with the provisions of this ordinance, are to the extent of such conflict hereby repealed.

**SECTION III**

That this Ordinance shall be in effect, when read, passed, and published according to law.
