

ORDINANCE NO. O-08-2023

AN ORDINANCE AMENDING THE “PERSONNEL AND PAY CLASSIFICATION PLAN” BY ADDING A PART-TIME CODE ENFORCEMENT OFFICER AND A PART-TIME FACILITIES MAINTENANCE WORKER

BE IT ORDAINED BY THE CITY OF FORT THOMAS, CAMPBELL COUNTY, KENTUCKY:

SECTION I

The City of Fort Thomas hereby adds two part-time positions to General Services, a Code Enforcement Officer and a Facility Maintenance Worker.

SECTION II

The City of Fort Thomas hereby amends and readopts the compensation ranges for two part time positions with the Personnel and Pay Classification Plan as identified in “Exhibit B” which is attached hereto, to be effective on July 1, 2022.

SECTION III

All ordinances, and/or parts thereof, in conflict with the provisions of this ordinance, are to the extent of such conflict, hereby repealed.

SECTION IV

This ordinance shall be effective when read, adopted, and advertised according to law.
