- Another audience member (did not provide name or address) requested that the city crews receive education about harmful and beneficial tree maintenance (example "mulch volcanos")

- A motion was made by Mike Rice and seconded by Barb Manyet to remove the Silver Maple in the ROW at 30 Riverview Ave. Motion Approved
