### **Ordinances and Orders**

<u>Ordinance O-14-2023:</u> An ordinance pertaining to a ten year renewal of the franchise agreement between Spectrum and the City of Fort Thomas was presented to council for a first reading. This ordinance will be laid over to the next regular meeting of council for consideration.

Prior to the first reading of the tax ordinance, Andy Ellison noted that he does not feel the tax rate should be raised by the 4% because in his opinion, the city has sufficient reserves.
